Although termites have been associated mainly with damage, only less than 10% of the species have actually been recorded as pests, obscuring their important ecological role in the breakdown of vegetative matter and their variety and complexity of structure, physiology, social behavior, caste differentiation and regulation, and other aspects of their biology. The concluding chapters deal with the introduction or interception of termites by humans and their association with fungi, as well as the relationships of termite hosts with termitophiles. Termite biologists, zoologists, botanists, ecologists, behaviorists, biochemists, endocrinologists, and economic entomologists will find this volume invaluable.
