To us hard up youngsters these tickets were too good to miss and the Area 2 Rover in particular was a big attraction as it covered the South Western main line from Waterloo to Woking as well as the Guildford to Redhill line, the latter being 100% steam worked until the end of 1964. The line from Waterloo of course carried the steam hauled trains from Waterloo to Basingstoke, Salisbury and Southampton and beyond, many of which stopped at Woking and so were ideal for us ardent train bashers.
