Degenerative diseases linked to ageing populations are a growing problem for the developed world. Pedoman WHO secara jelas telah menyatakan bahwa bidan/perawat terlatih diberikan kewenangan klinis melakukan krioterapi, namun peraturan dan kebijakan di Indonesia saat ini (Permenkes No. 29 tahun 2017 dan No. 34 tahun 2015) masih membatasi pada dokter umum terlatih sebagai pelaksana krioterapi. Berdasarkan pemikiran ini, sangatlah mendesak dilakukan perubahan kebijakan dalam hal ini Permenkes sebagai payung hukum dan legalisasi prosedur krioterapi di lapangan.
