A crucial responsibility for Christian interpreters of Scripture today, Richard Bauckham insists, is to seek to understand our contemporary context and to explore the Bible's relevance to it in ways that reflect serious critical engagement with that context. In The Bible in the Contemporary World Bauckham models how this task can be carried out. Bauckham calls for our reading of Scripture to lead us into increased engagement with the important issues of today's world, including globalization, environmental degradation, and widespread poverty. He works to bring biblical texts into relationship with these contemporary realities by means of the Bible's metanarrative of God and the world, in which God's purpose takes effect in the salvation and fulfilment of the world as his cherished creation.

Engaging Classical Texts in the Contemporary World

Daniel Lynwood Smith orients readers of the New Testament to its historical and cultural settings, introducing the cast of characters, and illuminating key concepts by exploring their use in ancient texts. Smith includes quotations from many primary sources including Josephus, Tacitus, the Qumran Community, Pliny the Younger, and other carefully chosen texts from lesser-known ancient sources. These texts are all carefully woven together with commentary, to provide a narrative framework for the material and guide students through the text. A glossary of complex terms is provided, to make everything as clear as possible for the newcomer to New Testament studies. This integrative approach both introduces the key sources to the reader and elaborates on their significance for understanding the New Testament. In an admirably concise format Smith is able to cover the military-political history of Israel-Palestine, the messianic movements of Second Temple Judaism, the ancient practice of crucifixion and the development of the Christian canon. Through immersion in these ancient Jewish, Christian, and Greco-Roman texts and contexts, contemporary readers take a step closer to

experiencing the New Testament with first-century eyes and ears.

Changes in Contemporary Ireland

The rise of printing had major effects on culture and society in the early modern period, and the presence of this new technology—and the relatively rapid embrace of it among early modern Jews—certainly had an effect on many aspects of Jewish culture. One major change that print seems to have brought to the Jewish communities of Christian Europe, particularly in Italy, was greater interaction between Jews and Christians in the production and dissemination of books. Starting in the early sixteenth century, the locus of production for Jewish books in many places in Italy was in Christian-owned print shops, with Jews and Christians collaborating on the editorial and technical processes of book production. As this Jewish-Christian collaboration often took place under conditions of control by Christians (for example, the involvement of Christian typesetters and printers, expurgation and censorship of Hebrew texts, and state control of Hebrew printing), its study opens up an important set of questions about the role that Christians played in shaping Jewish culture. Presenting new research by an international group of scholars, this book represents a step toward a fuller understanding of Jewish book history. Individual essays focus on a range of issues related to the production and dissemination of Hebrew books as well as their audiences. Topics include the activities of scribes and printers, the creation of new types of literature and the transformation of canonical works in the era of print, the external and internal censorship of Hebrew books, and the reading interests of Jews. An introduction summarizes the state of scholarship in the field and offers an overview of the transition from manuscript to print in this period.

Texts in Context

Being able to analyse different types of text is an essential skill for students of literature. Texts is a new kind of book which shows students how to use literary theory to approach a wide range of literary, cultural and media texts of the kind studied on today's courses. These texts range from short stories, autobiographies, political speeches, websites and lyrics to films such as The Matrix and Harry Potter and from television's Big Brother to shopping malls, celebrities, and rock videos. Each chapter combines an introduction to the text and aspects of its critical reception with an analysis using one of sixteen key approaches, from established angles like feminism, postcolonial studies and deconstruction to newer areas such as

ecocriticism, trauma theory, and ethical criticism. Each chapter also indicates alternative ways of reading the text by drawing on other critical approaches.

Children's Literature in Context

Children's Literature in Translation

Thomas Hardy

Contemporary classicists often find themselves advocating for the value and relevance of Greco-Roman literature and culture, whether in the classroom, or social media, or newsprint and magazines. In this collection, twelve top scholars apply major critical approaches from other academic fields to open new channels for dialogue between ancient texts and the contemporary world. This volume considers perennial favorites of classical literature—the Iliad and Odyssey, Greek tragedy, Roman comedy, the Argonautica, and Ovid's Metamorphoses—and their influence on popular entertainment from Shakespeare's plays to Hollywood's toga films. It also engages with unusual and intriguing texts across the centuries, including a curious group of epigrams by Artemidorus found on the island sanctuary of Thera, mysterious fragments of two Aeschylean tragedies, and modern-day North African novels. These essays engage an array of theoretical approaches from other fields—narratology, cognitive literary theory, feminist theory, New Historicist approaches to gender and sexuality, and politeness theory—without forsaking more traditional philological methods. A new look at hospitality in the Argonautica shows its roots in the changed historical circumstances of the Hellenistic world. The doubleness of Helen and her phantom in Euripides' Helen is even more complex than previously noted. Particularly illuminating is the recurrent application of

reception studies, yielding new takes on the ancient reception of Homer by Apollonius and of Aeschylus by Macrobius, the reception of Plautus by Shakespeare, and more contemporary examples from the worlds of cinema and literature. Students and scholars of classics will find much in these new interpretations and approaches to familiar texts that will expand their intellectual horizons. Specialists in other fields, particularly English, comparative literature, film studies, and gender and sexuality studies, will also find these essays directly relevant to their work.

The Hebrew Book in Early Modern Italy

Looking at musical globalization and vocal music, this collection of essays studies the complex relationship between the human voice and cultural identity in 20th- and 21st-century music in both East Asian and Western music. The authors approach musical meaning in specific case studies against the background of general trends of cultural globalization and the construction/deconstruction of identity produced by human (and artificial) voices. The essays proceed from different angles, notably sociocultural and historical contexts, philosophical and literary aesthetics, vocal technique, analysis of vocal microstructures, text/phonetics-music-relationships, historical vocal sources or models for contemporary art and pop music, and areas of conflict between vocalization, "ethnicity," and cultural identity. They pinpoint crucial topical features that have shaped identity-discourses in art and popular musical situations since the1950s, with a special focus on the past two decades. The volume thus offers a unique compilation of texts on the human voice in a period of heightened cultural globalization by utilizing systematic methodological research and firsthand accounts on compositional practice by current Asian and Western authors.

Postcolonial Literatures in Context

Featuring internationally renowned academics, this volume provides a snapshot of the field of applied linguistics, and illustrates how linguistics is engaging with the idea of 'context'. The book treats discourse as language in the contexts of its use in and above the level of the sentence and as systems of knowledge and beliefs. In using the term context(s), the book understands this as different situations in which discourse is produced and, on the other, how analysts construe context in their work. The volume is thus concerned with language in its context of use (little d discourse), but at the same time, more specifically, in individual chapters, with particular discourses as they are manifested in particular contexts (big D discourses). Well known discourse analysts contribute chapters focussing on different contexts with which they are familiar, viz. business, education, ethnicity and race, gender and sexuality, history, intercultural contexts, lingua franca contexts, media, place, politics, race, and the virtual world. It brings together researchers from different approaches, but all with a commitment to the study of language in context. The contributors themselves represent different approaches to discourse analysis: conversation analysis, corpus linguistics, critical discourse analysis, ethnographic discourse analysis, mediated

discourse analysis, multimodal discourse analysis, systemic functional linguistics. Readers are invited to compare and contrast these different contexts and approaches.

Texts and Contexts of the Oldest Runic Inscriptions

Examining materials from early modern and contemporary North India and Pakistan, Tellings and Texts brings together seventeen first-rate papers on the relations between written and oral texts, their performance, and the musical traditions these performances have entailed. The contributions from some of the best scholars in the field cover a wide range of literary genres and social and cultural contexts across the region. The texts and practices are contextualized in relation to the broader social and political background in which they emerged, showing how religious affiliations, caste dynamics and political concerns played a role in shaping social identities as well as aesthetic sensibilities. By doing so this book sheds light into theoretical issues of more general significance, such as textual versus oral norms; the features of oral performance and improvisation; the role of the text in performance; the aesthetics and social dimension of performance; the significance of space in performance history and important considerations on repertoires of story-telling. Tellings and Texts is essential reading for anyone with an interest in South Asian culture and, more generally, in the theory and practice of oral literature, performance and story-telling.

Tellings and Texts

In this volume David Horrell focuses on themes of community, ethics, and ecology in Paul, moving from the concrete social circumstances in which the earliest Christian communities gathered to the appropriation of Paul's writings in relation to modern ethical challenges. Often questioning established consensus positions, Horrell opens up new perspectives and

engages with ongoing debates both in Pauline studies and in contemporary ethics. After covering historical questions about the setting of the Paul-ine communities, The Making of Christian Morality analyzes Paul-ine ethics through a detailed study of particular passages. In the third and final section Horrell brings Pauline thought to bear on contemporary issues and challenges, using the environmental crisis as a case study to demonstrate how Paul's ethics can be appropriated fruitfully in a world so different from Paul's own.

Complex TV

This edition of Othello reprints the Bevington edition of the play accompanied by six sets of thematically arranged primary documents and illustrations designed to facilitate many different approaches to Shakespeare. The text includes tracts on marriage, travel literature, military manuals, maps, ballads, royal proclamations, early modern descriptions of Africa and the Middle East, nineteenth-century scripts for performances of Othello, and scenes from contemporary re-envisionings of the play. The primary documents contextualize race and religion in the Renaissance, gender relations, military life, the passions, the notion of the "Other" in early modern England, and the afterlife of Othello on the stage.

The ending of the Troubles and signing of the Good Friday Agreement similarly heralded a new era in terms of positive political change, but recent paramilitary activity threatens to undermine the progress made in the 1990s, as waves of new violence hit the North. Equally, recent economic recession has halted the radical growth seen in the Republic over recent decades. This book therefore problematises the concept of change and progress by juxtaposing these events, and asking what real changes can be traced in modern Ireland. The contributors frequently reflect on the changes and upheavals this period of dramatic economic, political and cultural change has prompted. The volume includes contributions from the fields of politics, cultural studies, sport, history, geography, media and film studies, and theatre and literature. As such it is a decidedly interdisciplinary study, exploring wide-ranging topics and issues relevant to contemporary Irish Studies.

Shakespeare

Humanity: Texts and Contexts is a record of the 2007 Singapore "Building Bridges" seminar, an annual dialogue between Muslim and Christian scholars cosponsored by Georgetown University and the Archbishop of Canterbury. This volume explores three central questions: What does it mean to be human? What is the significance of the diversity that is evident among human beings? Texts and Contexts

First published in 2008, Afro-Europe: Texts and Contexts is now finally available to a wider public. This book explores new literary and cultural configurations in contemporary Europe, providing insight into a thriving but yet little-known cultural phenomenon. Its focus is on the literary production of people of African origin as well as on the various socio-political contexts, theoretical paradigms and institutional discourses in which it is conceived, circulated and received. The essays contained in this volume contribute to spreading knowledge about Afro-European cultures and to establishing Afro-European Studies as a crucial field of research. The author outlines a theoretical framework for comparative work across national and linguistic borders.
